What is the NSW telecommunications facilities guideline including broadband?

The NSW Telecommunications Facilities Guideline Including Broadband supports the roll out of broadband in NSW and aims to ensure that both wireline and wireless telecommunications infrastructure, including for broadband, can be provided in an efficient and cost effective manner to meet community needs for telecommunications services.

When did the connection charge guidelines for electricity customers come out?

On 6 April 2023, the AER released its final Connection charge guidelines for electricity customers and accompanying explanatory note in light of changes made to the NER in August 2021. Minor, administrative changes were made to these Guidelines in October 2024 to account for the Integrating Energy Storage Systems rule change.

Who approves a mobile phone base station?

There are rules and standards telcos must follow to install mobile phone base stations. The decision on who approves a base station depends on several planning factors, including: the classification/zoning of the land.

What are the AEMC's obligations under the National Electricity Rules?
